WITHDRAWAL & TRANSFER POLICY

Withdrawals

Our commitment to service guarantees that you will receive personal assistance in making changes should you need to cancel or withdraw from the trip. If you choose to cancel or withdraw, The Crossing must be notified by email or phone. The date of your email or phone call will establish your cancellation date and determine what non-refundable fees will apply.

Refunds

There are no refunds for any out-of-pocket costs The Crossing incurs, e.g. the purchase price of your airline ticket. Refunds are available for any amount paid that exceeds any cost The Crossing incurs within the date guidelines listed above. Refunds are made for extreme situations only, and will be dealt with on a case-by-case basis by contacting the trip representative at The Crossing.

Cancellation by The Crossing Church

In the event a trip is cancelled (at The Crossing's discretion) due to the minimum team size requirement not being met, to terrorism, civil unrest, natural disaster or man-made disasters, wide spread illness, pandemic or other extraordinary events, and your team is not willing or able to transfer to another available location, a full refund will be issued for all funds paid or raised by each individual.

Additional Cost Responsibilities

The Crossing will pay for any costs associated with an error in the administration or planning of the trip. (i.e., name misspelled). The Crossing will cover the cost, in conjunction with our Trip Insurance, if a traveler **MUST** be transported home. (i.e., medical emergency, family emergency). Trip Participants will be responsible for covering the cost for any travel arrangements outside of the pre-planned trip itinerary including, but not limited to sightseeing, changes to their travel dates, or flight upgrades. Trip Participants will be responsible for covering any expenses incurred due to traveler error including, but not limited to events such as expired passport, providing false information, or incorrect information. If participants are asked to return home early they will have to pay to return home at their own expense.
